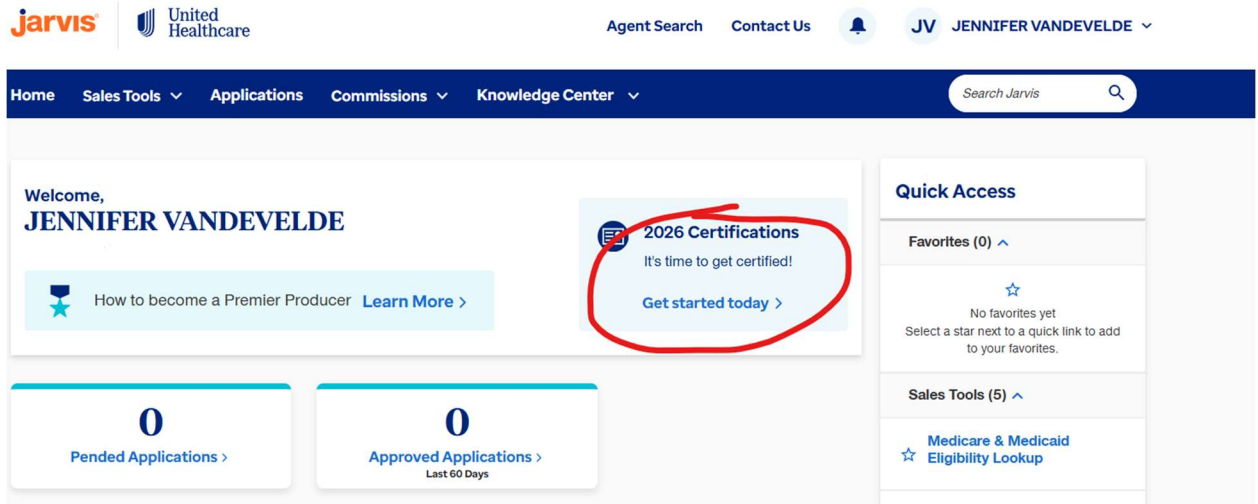
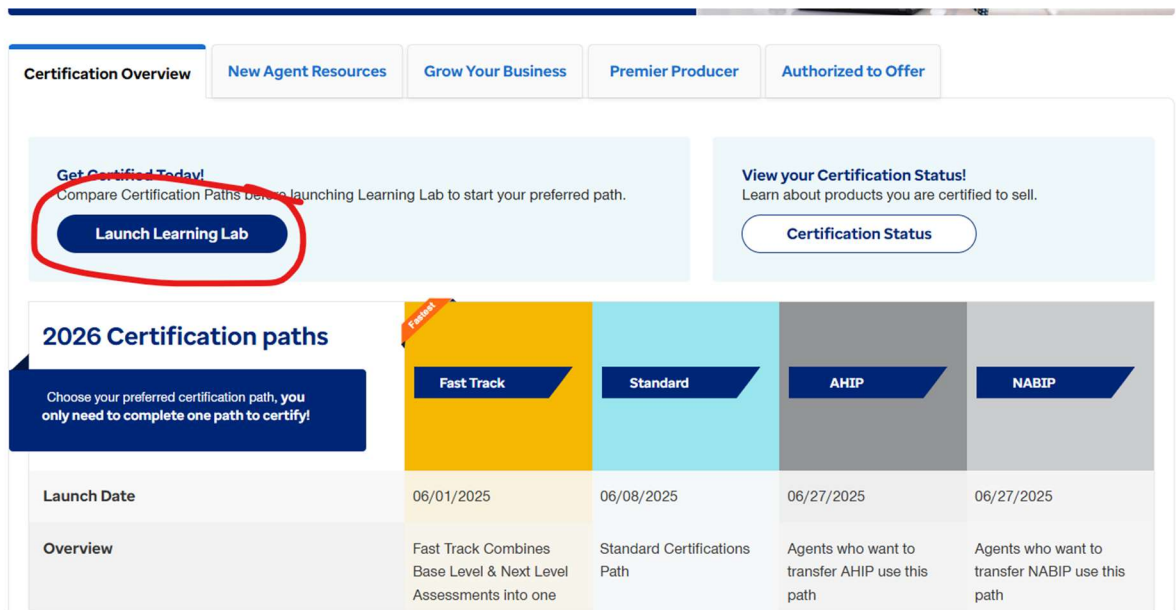


UHC – 2026 Certification Instructions

1. Log into UHC Jarvis.
2. From the home page, select “Get started today” under “2026 Certifications”

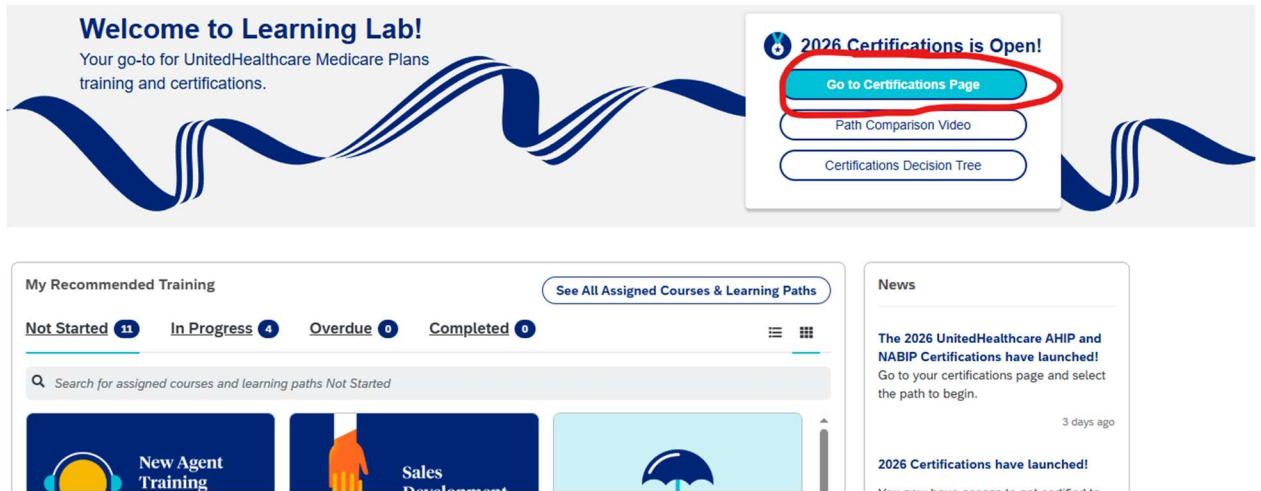


3. Select “Launch Learning Lab”

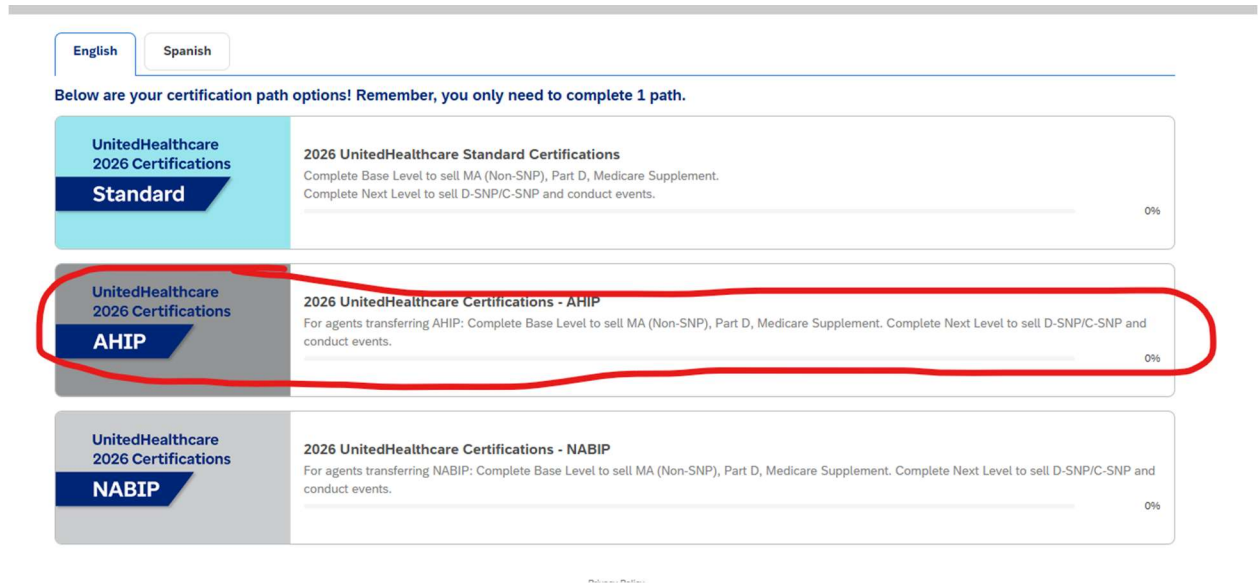

5. Select the certification path that suits your needs. (Standard is for agents who do not take the AHIP/only sell Medicare Supplements. AHIP is for the agents that will transfer their AHIP scores to UHC, and NABIP is for the agents that will transfer their NABIP scores). Most agents will select the AHIP route. (Please note that you must complete the AHIP before beginning the AHIP certification path for UHC.)
